1 Certificate of Conformance and Logo Usage Guidelines



Vendors that earn an ONF Certificate of Conformance gain the right to use the globally-recognized ONF OpenFlow Conformant logo for their compliant products and website. The logo identifies the version of the OpenFlow specification to which the product conforms.

The Logo can be used on physical products, software, documentation, websites, and marketing material, as described in the [ONF trademark and logo guidelines](#), and must comply with the additional guidelines below:

- The Certificate of Conformance and Logo can only be used for the specific product certified and for the specific test program it was tested with.
- The Certificate of Conformance and Logo applies to the Product Version Release tested.
 - New releases, if they differ in functionality, behavior or negatively change the test results in any way, need to be recertified.
- The Certificate of Conformance and Logo cannot be used generically or claim that all products of that company are certified.

Note: Certification does not guarantee interoperability.
